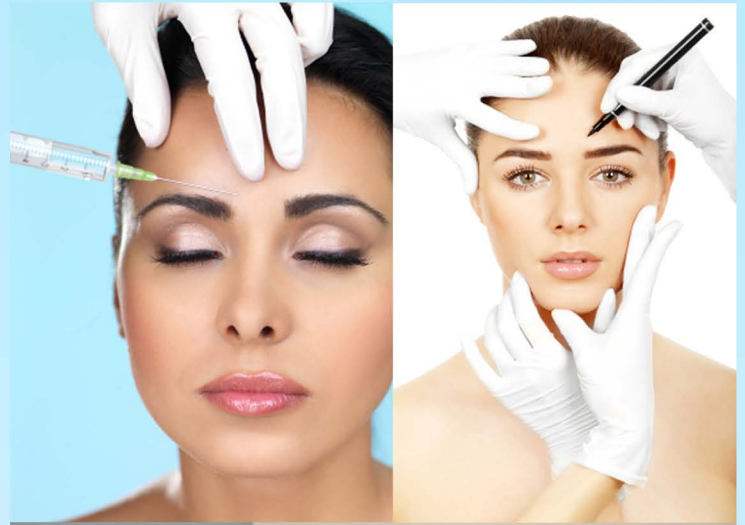

## Broad Spectrum Light Package Intro

and Skin Rejuvenation  
Lease payment approximately \$700/month\*  
Average treatment charge per client = \$300  
Treatment Series per client = 4 to 6 treatments spaced 4-6  
weeks apart  
**\$12,000 per month cash flow**  
**(2 treatments/day @ \$300 each)**

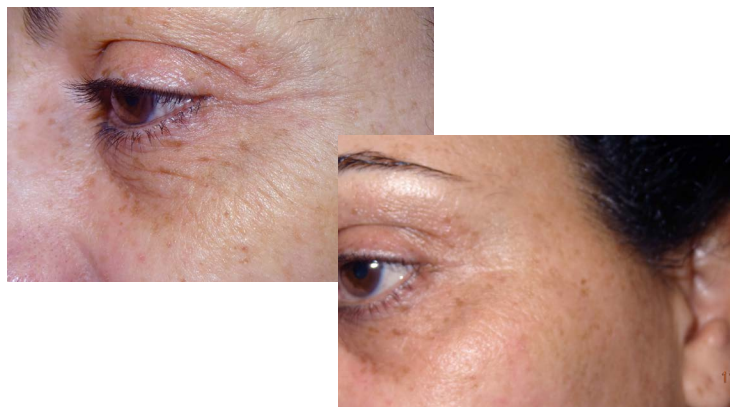
